



Affidavit for Military Surplus Vehicle

I hereby attest to the following facts and information:

I understand that any false statement submitted in this affidavit subjects me to prosecution pursuant to Title 47 Section 4-108 of the Oklahoma Statutes.

As required by Title 47 Section 1-171.1(A) of the Oklahoma Statutes, I affirm that this vehicle:

1. Has three axles or fewer and meets the legal size and weight limits set forth in 47 OS 14-103;
2. Is less than 35 years old, and may not be a tracked vehicle;
3. Has for each occupant, safety belts or safety shoulder harnesses which shall be installed pursuant to 49 C.F.R., Section 571.208 et seq.;
4. Has equipment required on vehicles pursuant to 47 OS 12-201 through 12-232, including:
 - a. § 12-203 – At least 2 head lamps;
 - b. § 12-204 – At least 2 tail lamps;
 - c. § 12-204.1 – Not more than 2 rear license plate lamps;
 - d. § 12-205 – At least 2 red reflectors on the rear of the vehicle;
 - e. § 12-206 – At least 2 stop lamps on the rear of the vehicle;
 - f. § 12-206.1 – Turn signals that flash to the front and rear of the vehicle;
 - g. For vehicles over 80 inches wide the following lamps and reflectors meeting the requirements of § 12-208 and § 12-211:
 - i. 2 front amber clearance lamps
 - ii. 2 rear red clearance lamps
 - iii. 2 side marker lamps (front is amber, rear is red)
 - iv. 2 reflex reflectors (front is amber, rear is red); and
 - h. § 12-220 – Not more than 2 back-up lamps;
 - i. § 12-220 – Vehicular hazard warning lamps.

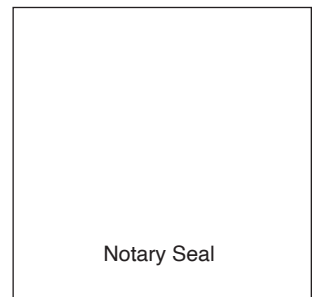
