PURPOSE To provide up-to-date weekly epidemiological data on COVID-19 in Oklahoma.

- 494,085 vaccine doses have been administered in total



The youngest individual to die from COVID-19 was less than 15 years and the oldest was **100+ years**.









JOHNS HOPKINS 7 DAY AVERAGE POSITIVITY RATE FOR SPECIMEN AND ANTIBODY CASES















Distribution of recovered cases of COVID-19, March 2020 - February 2021, Oklahoma












Total number of reported COVID-19 cases




Cumulative incidence of reported COVID-19 cases



Total number of reported COVID-19 deaths





Cumulative death rate of reported COVID-19 cases





Cumulative incidence of reported COVID-19 cases in last 7 days





Total number of reported COVID-19 deaths in last 7 days






