Weekly Epidemiology and Surveillance Report January 23-29, 2022



PURPOSE To provide up-to-date weekly epidemiological data on COVID-19 in Oklahoma.

KEY POINTS

- **62,852** cases were reported in the last week, 18.7% decrease from the week before (Jan 16-22).
- 149 deaths were reported in the past week.
- The cumulative crude case-fatality risk is 1.2%

- 40,610 (4.2%) cases have been hospitalized. The cumulative hospitalization rate is 1026.3 per 100,000 persons.
- *137,100 specimens have been reported over the last 7 days according to the CDC COVID data tracker. * Counts reflect the tests reported since Jan 26.
- 4,575,753 vaccine doses have been administered in total


















COVID-19 DAILY TESTS PERFORMED AND 7 DAY MEAN PERCENT POSITIVITY











Cumulative death rate of reported COVID-19 cases





Cumulative death rate of reported COVID-19 cases in last 7 days



Weekly number of deaths (from all causes)


