2. Newly reported deaths had dates of death ranging from 2021 and May 2022 with the majority occurring in May 2022. Please refer to the graph on page 9 which shows when newly reported death occurred.

### **CDC PAUSE ON DEATH CERTIFICATE DATA**

Starting June 6, 2022 there will be a nationwide, temporary pause in the processing of death certificate data.

The National Vital Statistics System (NVSS) will be undergoing a system-wide upgrade. During the pause Oklahoma will continue to report to the CDC and NCHS, but the pause will result in the state not receiving data back as we normally do. This means the provisional death counts for COVID-19 will not be updated for several weeks and likely multiple releases.

We will report data occurring during the paused time frame, once processing resumes. For more information visit,























## **Cumulative death rate of reported COVID-19 cases**









### Weekly number of deaths (from all causes)


