PURPOSE To provide up-to-date weekly epidemiological data on COVID-19 in Oklahoma.

^{1.} Weekly case total is based on the number of cases with a symptom onset/specimen collection date in the given time frame. The cumulative total includes new cases as well as older cases identified as a result of delayed reported.

2. In the past week, errors were identified for two previously reported deaths. One of these deaths was a duplicate that had previously been reported. The other death was for an individual that was not an Oklahoma resident. This death was removed from our state count once the correct state of residence was notified so that the death is not counted in both states.

CDC PAUSE ON DEATH CERTIFICATE DATA

Starting June 6, 2022 there will be a nationwide, temporary pause in the processing of death certificate data.

The National Vital Statistics System (NVSS) will be undergoing a system-wide upgrade. During the pause Oklahoma will continue to report to the CDC and NCHS, but the pause will result in the state not receiving data back as we normally do. This means the provisional death counts for COVID-19 will not be updated for several weeks and likely multiple releases.

We will report data occurring during the paused time frame, once processing resumes. For more information visit,














COVID-19 VARIANT STRAINS SEQUENCED*









Cumulative death rate of reported COVID-19 cases





Cumulative death rate of reported COVID-19 cases in last 7 days





Weekly number of deaths (from all causes)


