













Lineage Omicron - BA.2.12.1 Omicron - BA.4 Omicron - BA.5


Monthly Proportion of Variant Lineages, Oklahoma, January 1, 2021 - August 23, 2022 (N=25,788)







Cumulative death rate of reported COVID-19 cases







Weekly number of deaths (from all causes)


