






Variant Proportions by Region, Dates of Specimen Collection: October 8, 2022 - October 17, 2022, (N=18):


Monthly Proportion of Variant Lineages, Oklahoma, January 1, 2022 - October 31, 2022 (N=13,772)




## 2022 CASES, PERCENT HOSPITALIZED, AVERAGE LENGTH OF STAY AND DEATHS BY AGE GROUP



## Cumulative death rate of reported COVID-19 cases







#### Weekly number of deaths (from all causes)


