PURPOSE To provide up-to-date weekly epidemiological data on COVID-19 in Oklahoma.

1. Weekly case total is based on the number of cases with a symptom onset/specimen collection date in the given time frame. The cumulative total includes new cases as well as older cases identified as a result of delayed reported.

Note: Cases and deaths, reconciled through OSDH epidemiology investigations are reflected in the epidemiology reports on Dec. 1, 2022 and Dec. 8, 2022. Approximately 1,354 cases from 2021 were added along with 267 deaths through this reconciliation process. For more detail on when the deaths occurred, please see the chart on Pg. 8.

Other data points on the weekly epidemiology report that will have shifts include age, sex, and race of cases. Shifts are due to the OSDH team doing data quality assurance to have the most accurate data to evaluate the effect of COVID-19 over the past few years.


















COVID-19 VARIANT STRAINS SEQUENCED*




Monthly Proportion of Variant Lineages, Oklahoma, January 1, 2022 - November 29, 2022 (N=14,856)




2022 CASES, PERCENT HOSPITALIZED, AVERAGE LENGTH OF STAY AND DEATHS BY AGE GROUP



Cumulative death rate of reported COVID-19 cases







Weekly number of deaths (from all causes)


