STATE QUESTION NO. 603

LEGISLATIVE REFERENDUM NO. 263

This measure would add a new Section 64 to Article V of the State Constitution. This measure would allow either the Senate or the House of Representatives alone to disapprove a rule made by a state entity. The Legislature would be able to enact laws on rules. Among other things, the Legislature could exempt state entities from such laws. The Legislature could also provide time limits and allow review or appeal of rules. The Legislature could empower state entities to adopt, amend or repeal rules. The Legislature could require that rules be filed with it.

STATE QUESTION NO. 604

LEGISLATIVE REFERENDUM NO. 264

This measure amends Article 10 of the State Constitution. It would add a new Section 10B to Article 10 of the State Constitution. It would allow cities to vote extra millage. Tax dollars would be used to run city-owned hospitals. The people within a city would have to approve such taxes. The most extra millage for this purpose would be five (5) mills on the dollar value of property.

STATE QUESTION NO. 616

LEGISLATIVE REFERENDUM NO. 273

The measure amends Section 27 of Article X of the State Constitution. The measure would expand the way certain city and town bond issues could be used. Currently, cities and towns can issue debt to pay for buying, building, or repairing city-owned public utilities. This measure would add certain purposes for which the debt could be used. The added purposes would be building, rebuilding, improving or repairing streets or bridges.

STATE QUESTION NO. 617

LEGISLATIVE REFERENDUM NO. 274

This measure would add a new section to Article XI of the Oklahoma Constitution. It would allow the Commissioners of the Land Office to grant commercial and agricultural leases in trust land. The granting of any interest in trust land at less than fair market value would be void. The granting of any interest in trust land which is not in compliance with this section would be void. Any commercial lease for longer than three years must be done by public bidding. All agricultural leases must be done by public bidding. Commercial leases are limited to not more than fifty-five years. Agricultural leases are limited to not more than five years. Permanent improvements on leased land remain with the trust at the end of the lease. The Legislature must enact laws to ensure that the trust land is managed in a fair and equitable manner.

STATE QUESTION NO. 618

LEGISLATIVE REFERENDUM NO. 275

This measure would amend the State Constitution. It would change Section 6B of Article X. The term "manufacturing facility" is defined in this section. The change would delete this definition. It would require the Legislature to define this term by law. The term would be defined for purposes of the property tax exemption granted to new or expanding industry. It would be defined to promote full employment in the state. Once a facility qualified for the exemption, it would not lose the exemption because of a change in the way the term is defined.

STATE QUESTION NO. 610

LEGISLATIVE REFERENDUM NO. 267

This measure would add a new Section 42 to Article X of the Oklahoma Constitution. It would allow the Oklahoma Development Finance Authority to issue bonds. The bonds would be general obligation bonds. Not more than One Hundred Million Dollars worth of bonds could be issued. Any such bonds issued would be used to provide a reserve fund for the Authority. The fund would be the economic development credit enhancement reserve fund. The fund could only be used to pay debts issued by the Authority after all other pledged monies and reserve funds are used to the extent allowed by law to pay the debts. The Legislature would provide for the monies to pay for the bonds.

LEGISLATIVE REFERENDUM NO. 268

This measure would amend Section 15 to Article X of the Oklahoma Constitution. It would let state monies be used to make grants, loans and investments. The grants, loans and investments would be used to develop business in this state. The Oklahoma Center for the Advancement of Science and Technology would make the grants, loans and investments. The grants and loans would be to persons and companies. The investments would be made in private projects. The Legislature would have to approve the use of state monies for such purposes. The approval must be by a two-thirds vote in each house. It requires the Legislature to review said use of state monies.

STATE QUESTION NO. 612

LEGISLATIVE REFERENDUM NO. 269

This measure amends Section 8 of Article II of the Oklahoma Constitution. It expands the types of crimes for which bail may be denied. It allows bail to be denied to a person who commits a violent offense. It allows bail to be denied to a person who commits an offense which is punished by life imprisonment or life imprisonment without parole. It allows bail to be denied to a person who commits a felony offense after the person has been convicted of two or more felony offenses. It allows bail to be denied to a person who commits certain drug offenses. Bail may be denied for the specified offenses only if proof of guilt is evident and the safety of the community or of any person is not assured. This amendment shall become effective on July 1, 1989.

STATE QUESTION NO. 613

LEGISLATIVE REFERENDUM NO. 270

This measure would amend the State Constitution. It would change Sections 1 and 4 of Article VI. It provides that the Commissioner of Labor be elected by the people. The term of office of the Commissioner of Labor would be four years. At present the Commissioner of Labor is appointed by the Governor.
