RULE IMPACT STATEMENT

A. Brief description of the purpose of the proposed rule.

The purpose of the proposed rule amendments to Subchapter 3 are to follow the statutory requirements set forth in Section 14-108 of Title 70 of the Oklahoma Statutes by outlining the procedure for zoning technology center school districts that serve seventy or more public school districts and technology center school districts having a population of more than two hundred twenty-five thousand (225,000) electors.

B. Description of the classes of persons who most likely will be affected by the proposed rule, including classes that will bear the costs of the proposed rule, and any information on cost impacts received by the agency from any private or public entities.

Electors residing in the technology center school districts described above. There is a potential cost impact to the technology center school district associated with rezoning if an election is required.

The individuals residing within the technology center school districts described above.
