





## Legislation passed during the 2023 Session:

- S.B. 93 Graduation Requirements- Mandates the completion of the Free Application for Federal Student Aid in order to graduate high school, subject to certain opt-outs. Beginning 2024-2025
  - Requires every student must complete and submit the FAFSA in order to graduate from a public high school.
  - Allows students to be exempt if their parents or legal guardians submit a signed form opting them out of the requirement, if a student aged 18 or older submits a signed form opting them out of the requirement, or if a school counselor authorizes a student to opt out of the requirement.
  - Requires OSDE to develop and publish materials for students, parents, and legal guardians explaining the requirements, the benefits, and the opt-out provisions. Requires SDE develop and publish an opt-out form to be used by schools.





# Legislation passed during the 2023 Session:

- **S.B. 100** became effective July 1, 2023. This bill requires every school district to undergo a risk and vulnerability assessment by July 1, 2023.
  - Allows Risk and Vulnerability assessments of school districts including recommendations and preparations for assessments to be kept confidential.
  - Requires every school district who has not completed a risk and vulnerability assessment within the past two years must complete one by July 1, 2026.
  - Requires that every school district complete a risk and vulnerability assessment every 5 years.
- **S.B. 429** became effective July 1, 2023. This bill allows student to wear tribal regalia during graduation ceremonies.
- **H.B. 1041** became effective July 1, 2023. This bill allows individuals school districts to issue alternate diplomas.
