




Updates to Application






Updates to Examiner Training

- **Streamlined Training:** Some activities have been removed to simplify and focus the training experience.
- **Step-by-Step Format:** The process now mirrors the structure of the application for a more consistent experience.
- **Confirmation Certificate:** Examiners will receive a certificate once all steps are completed, serving as official confirmation.
- **Examiner Orientation:** We will be hosting an examiner orientation in June, designed for new examiners and those who have not participated in a visit recently. This brief 15–20 minute session will walk participants through the visit process and outline next steps, ensuring they know what to expect.



Federal Student Aid by the Numbers

Eligible programs= 885 (eligible for Title IV in 24-25 year)

- Fulltime (postsecondary)
- Approved by division program specialists
- Minimum 600 hours
- Certification
- Gainful Employment
- Services, Follow-up

2023–2024 Academic Year

- 3293 adult students in fulltime across 28 technology center districts received Pell
- Average grant per student = \$4,940
- Total Pell disbursed = \$16,266,221
