

Certified Healthy School Frequently Asked Questions

Benefits

Q: Why is becoming Certified Healthy important to my school?

A: Certified Healthy School recipients may be eligible to apply for an incentive grant. Certified Healthy is a free assessment tool to see where your school stands on supporting health and to show recognition to schools that go 'above and beyond' to create a healthy, nurturing environment.

Eligibility

Q: What qualifies as a School?

A: Any public or private school that educates Pre-Kindergarten through 12th grade.

Q: If I was a Certified Healthy School last year, do I need to reapply?

A: Yes, applicants must re-apply each year for certification.

Q: My school is state mandated smoke-tobacco free. Do I need to have a written policy?

A: In order for a school to achieve Excellence, a school must enforce a 100% tobacco-smoke free written policy that applies to the entire property under their control, both indoors and outdoors; the policy must apply to all people, at all times. Please submit a copy of the policy with the CHO application.

Application Process

Q: When can I apply?

A: The application period runs from August 1st to November 1st.

Q: Where do I apply?

Q: Can I mail or fax my application?

A: No, all applications must be completed online. We will not accept mailed or faxed applications.

Q: How will I know if my application was submitted successfully?

A: You will receive a confirmation e-mail if your application is submitted successfully. If you do not receive this e-mail, first check your spam to see if it was sent there; if it is not there, please contact the Certified Healthy Oklahoma Team and verify if it went through successfully. If it did not, you will need to re-submit.

Q: I work with multiple school sites. Does each one need to apply?

A: As policies and procedures vary by location, we encourage applicants to submit an application for each site. Public schools should apply per site as designated by the Oklahoma State Department of Education. Also, we encourage the district offices to apply as a business, rather than a school.

Q: My school has an early childcare program connected to it. Should I apply as an early childhood program as well?

A: Yes, we encourage early childhood programs connected to and/or affiliated with a school to apply separately.

Q: I am having technical issues with the application and/or website. Who can I call?

Q: I have entered my county/school district name on the application, and I received an “invalid school district” or “invalid county” code at the top of the application. Why did I get this code?

A: The application is designed to accommodate specific responses. You will need to type in only your district or county name (i.e. “Carter” instead of “Carter County” or “Idabel” instead of “Idabel School District”). The list will pre-populate as you type. Try typing in the first 3 letters of the district name or County and select from the pre-populated list that appears. The application will not allow the user to move to the following page if the information is not put in exactly the way the system recognizes.

Q: When will the awardees be announced?

A: We will send out award decisions in December.

Q: When is the awards ceremony and how much does it cost?

A: The awards ceremony is typically held between March and April, and cost varies each year.

Criteria

Q: How many criteria are there on the school application?

A: There are 87 criteria total in nine categories.

Q: Are the criteria different from last year?

A: The criteria were updated in 2019 and aligned with the WSCC Model. All Certified Healthy Oklahoma criteria are updated biennially to reflect the latest best and promising practices.

Q: Where did these criteria come from?

A: The Certified Healthy School criteria are based on the Coordinate School Health model, which is now the WSCC model--Whole School, Whole Community, Whole Child--and is aligned with the School Health Index Assessment Tool.

Q: I need help understanding a criterion. What should I do?

Scoring

Q: How will my application be scored?

A: We strive to be as transparent as possible with scoring. We use specific points for scoring, and applicants are scored based on the points of criteria checked in *each* category. Q: How many criteria do I need to check in each category to be certified?

A: Please see the scoring information on [Certified Healthy School \(oklahoma.gov\)](https://www.oklahoma.gov/education/certified-healthy-school). The number of criteria needed for certification varies by certification level.

Q: I did not receive certification last year. How can I improve my score this year?
