2. Quorum

4. Case No. 2025-001 - Complaint Against Allan Guenther

Overview: The Board held individual proceedings regarding a complaint against Alan Guenther, Massage Therapist License No. 173112. A motion was approved authorizing CAAG Maule to open the record, lead discussion on the proposed consent order, and provide legal guidance. The hearing was formally called to order, confirming a quorum and board jurisdiction. A roll call confirmed that no board members had conflicts of interest. Prosecutor Kylie Cooper stated that the parties had agreed to a consent order, in lieu of a hearing, involving charges of violating Board Rule 2091 I—performing breast massage without written consent. Mr. Guenther and counsel were not present.

• Proposed Consent Order:

The proposed consent order included: two years of probation, a chaperone requirement for female clients, a \$1,000 fine, \$500 in costs, and 12 hours of continuing education in ethics, client boundaries, and consent. The Board entered executive session to deliberate.

Overview: Chair Sinclair moved this item on the agenda from #5 to #4, opting to discuss it second. Recommendations were presented by CAAG Maule regarding the agency's legislative status, as the Oklahoma State Board of Cosmetology and Barbering is currently set to sunset on July 1, 2025, pending legislative override. Due to this uncertainty, the Board voted to table the Thentia contract.

- **Conclusion:** The Board did not engage in discussion on this topic, following legal counsel's advice to table the item until more information is available regarding the agency's future.

6. Attorney General Contract for State Fiscal Year 2026

Overview: Chair Sinclair moved this item on the agenda from #6 to #3, opting to discuss it first. A motion was made to proceed with the same contract as presented; however, recommendations were presented by CAAG Maule regarding the agency's legislative status, as the Oklahoma State Board of Cosmetology and Barbering is currently set to sunset on July 1, 2025, pending legislative override. Due to this uncertainty, the Board voted to table the Attorney General contract. CAAG

Maule confirmed that conversations with OMES have taken place, and a list of outstanding contracts has been requested. The Board acknowledged that the legislature must act by the last Friday in May—or before sine die adjournment—to ensure the agency's continuation.

- **Conclusion:** The Board did not engage in discussion on this topic, following legal counsel's advice to table the item until more information is available regarding the agency's future.

7. Veto of HB 1030 – Sunset Extension for Board of Cosmetology

Overview: The Board discussed the serious implications of Governor Stitt's veto of House Bill 1030, which would have extended the Oklahoma State Board of Cosmetology and Barbering's

authority beyond July 1, 2025. If the veto stands, the agency faces abolishment, placing public health, industry standards, and nearly 77,000 licensees at risk.

Legislative and Administrative Context:

An override of the veto requires a two-thirds majority in both legislative chambers before the last Friday in May. Despite this late stage of session, some optimism remains, as several lawmakers and stakeholders have expressed interest in helping pursue an override. Meanwhile, OMES has offered assistance with a Reduction in Force (RIF) plan in the event of agency closure, which must be approved and ready by May 22, and would provide employees with 30-day notice and potentially severance benefits. Member Callicoat commented and asked for clarification and CAAG Maule explained.

Concerns About Transition and Public Messaging:

A Service Oklahoma link implying transition has caused concern and confusion, especially since no formal legislation currently transfers the agency's functions. The Board acknowledged the need to better prepare staff and communicate transparently with licensees. Additionally, House Bill 2728—currently awaiting the Governor's signature—would authorize OMES to assume limited oversight but does not formally relocate the agency. The Governor's transparency regarding these unfolding events was called into question. Vice Chair Miller, Member Callicoat, and Chair Sinclair commented and asked for clarification. CAAG Maule and AAG Cooper explained. Member Luther and Chair Sinclair elaborated.

Impact on Licensing and Public Safety:

If the agency sunsets, licenses will remain valid only until their expiration dates. No renewals or new licenses would be issued after July 1, leading to an unregulated industry. The Board emphasized that no other U.S. state operates without cosmetology regulation, raising significant public safety concerns. Chair Sinclair, Member Callicoat, Member Luther, and Member Jackson requested clarification and CAAG Maule explained.

External Support and Advocacy Efforts:

Organizations such as NIC and NABBA are preparing letters of support for legislative leaders, highlighting the national implications of Oklahoma potentially becoming the only state without a regulatory body for cosmetology and barbering. Chair Sinclair and Member Callicoat commented.

- Conclusion: Chair Sinclair, Member Callicoat, Vice Chair Miller, and Member Luther stressed
 the urgency of the situation, the necessity for licensees to contact legislators, and the
 importance of a legislative override or special session to ensure continued regulation and
 agency operation. Without such action, the agency will be dismantled, and Oklahoma would
 face a regulatory void.
