LEVEL ASSIGNMENT:

Only offenders with applicable convictions or probationary periods on or after November 1, 2007, will be assigned a level.

An offender assigned to level one must register for a total of 15 years with annual address verification.

An offender assigned to level two must register for a total of 25 years with address verification every six months.

An offender assigned to level three must register for life with address verification every 90 days.
