

## RULES AND CONDITIONS FOR GPS SURVEILLANCE PROGRAM

1. I will report as directed to the orientation scheduled on the date, time and place directed.
2. I will obey all city, state and federal laws. I will not own or possess a firearm, firearm parts (inoperable or ornamental) or travel in a vehicle containing a firearm belonging to me or anybody else. I will also not own or possess any swords, martial arts weapons, hunting knives, mace, tasers, or stun guns. I understand that at any time or place, I am subject to search. In addition, my vehicle and any property under my control are subject to search. I understand that I am subject to both state and federal laws concerning the purchase ownership and use of a firearm. I will not, under any circumstances, leave the State of Oklahoma. I will obtain permission before leaving the county of my approved residence.
3. I will report as directed by my officer in person and in writing on the forms provided by my officer. I will follow directives given to me by any ODOC and/or monitoring center employee. I understand that my officer will visit me at home, work, or any other place without restriction to time. I also understand that I will be required to wear an electronic security-monitoring device.
4. I will not use or possess drugs other than those legally prescribed by a physician. I will report to my officer any medications that I may be prescribed. I will not use alcohol nor go onto the premises of places where alcoholic beverages are served, to include beer parlors, taverns, clubs, group meetings or parties where alcoholic beverages are served. I will submit to urinalysis or other forms of drug detection.
5. I will not lie or misrepresent the truth to any member of law enforcement, any employee of the Department of Corrections, any monitoring center employee or any official of the government.
6. I understand that I am required to maintain full-time employment. If unemployed, I will be required to be actively searching for employment and provide verification of search to my officer.
7. I will pay program support fees of \$\_\_\_\_\_ per day for passive monitoring or \$\_\_\_\_\_ per day for active monitoring. Payment shall be by cashier's check or money order only and shall be payable to the Department of Corrections. If I am unable to pay, a fee waiver may be requested per OP-160701 entitled, "Collection of Probation/Parole Fees, Restitution and Program Support Fees."
8. I will not apply for any public, private or governmental assistance without prior approval from my officer.
9. I understand that I am subject to curfew restrictions which shall be determined by my officer.
10. I will not enter into any charge accounts or credit applications for loans other than for educational expenses.
11. I will comply with all lawful directives issued by my supervising officer or any member of the Department of Corrections.
12. I understand that if I cannot be located by my officers or if I fail to report as directed by my officer, I will be considered to have escaped custody of the Department of Corrections. I hereby waive all extradition rights and agree to return to the State of Oklahoma and the Department of Corrections when directed.
13. I understand that I cannot waive parole while assigned to the GPS Program. Waiver shall result in a disciplinary hearing and reclassification to higher security.
14. I will actively participate in the developed case plan and any subsequent amendments to the plan. Programs may include by are not limited to:
  - a. Substance Abuse Treatment
  - b. Employment
  - c. Education/Cognitive
  - d. Financial
  - e. Mental Health
15. I will not, without prior approval from my supervising officer, associate with any persons actively under any form of Department of Corrections supervision or with persons who have a criminal record. I will not communicate with any inmates of any penal institution, including county jails, except members of my immediate family, unless my officer gives me permission to do so.
16. I will comply with any directives issued to me pertaining to use and care of all GPS equipment and agree to comply with all directives contained in the "Inmate Orientation" Guidelines and Procedures.
17. I will maintain a suitable residence and will maintain phone service. I will have my officer's permission prior to changing residence.
18. I will not operate a motor vehicle without my officer's approval.
