Voter Registration Address Confirmation Notice



This is a **Voter Registration Address Confirmation Notice** from the Oklahoma State Election Board. Federal and State laws [52 USC §20507 and 26 OS §4-120.2] require us to confirm the voter registration residence addresses of selected voters every two years.

Please keep your voter registration active by confirming your registration address in one of two ways.

Confirm Online:

- Locate the 8-digit code (#####-##) printed **above your name** on the other side of this card.
- Log in to <https://okvoterportal.okelections.gov> or **scan the QR code**.
- Under Voter Services, select Respond to an Address Confirmation Notice.
- Enter the 8-digit code (#####-##) and follow the instructions.
- **Do not mail the Return Card.**



Confirm by Mail:

- Fill out, sign, and date the **Return Card**.
- Fold the card so that the State Election Board's address is on the outside.

RESPOND WITHIN 60 DAYS OF RECEIPT.

Failure to respond to this notice could result in the cancellation of your voter registration following the November 2028 General Election with no additional notice provided.
