## FINDINGS AND ORDER

The above-styled cause was heard by the Election Board of the State of Oklahoma on April 23, 2018, meeting pursuant to lawful notice.

The following members of the State Election Board ("Board") were present: Steve Curry, Chair; Tom Montgomery, Vice-Chair; and Dr. Tim Mauldin, Member. Also present were Paul Ziriax, Secretary; and counsel for the State Election Board, Lyn Martin-Diehl, Assistant Attorney General; and Rachel Rogers, Assistant Attorney General. Also present, but not participating were Jerry Buchanan, Alternate Member; and Debi Thompson, Alternate Member.

Petitioner Wayne Eidson appeared in person without counsel. Contestee Eddie Paul Hunter did not appear.

The Petition was filed and Notice of Hearing issued on April 17, 2018, at 4:59 p.m. The Board received proof from the Petitioner that the Murray County Sheriff was unable to serve the Contestee within 24 hours of setting the Petition for hearing, as required by 26 O.S. § 5-124. The Petitioner served the copy of the petition and notice of the hearing upon the Secretary of the State Election Board on the date of the hearing, which constitutes constructive service pursuant to 26 O.S. § 5-125.

Contestee did not submit a cashier's or certified check in the amount of \$250.00, as required by 26 O.S. § 5-129.

The Board made the following findings of fact and conclusions of law:

- 1. Mr. Eidson filed with the Board a Declaration of Candidacy for the office of State Representative, District 22, during the filing period of April 11-13, 2018.
- 2. Mr. Hunter filed with the Board a Declaration of Candidacy for the office of State Representative, District 22, during the filing period of April 11-13, 2018.
- 3. The Board received proof of the Murray County Sheriff's inability to serve the Contestee within 24 hours of setting the Petition for hearing, as required by 26 O.S. § 5-124.

- 4. Mr. Eidson served the copy of the petition and notice of the hearing upon the Secretary of the State Election Board on the date of the hearing, which constitutes constructive service pursuant to 26 O.S. § 5-125.
- Title 26 O.S. § 5-129 requires a contestee, at the time of filing his or her answer 5. to the contest, or, if no answer is filed, at the time of his or her appearance, to deposit with the secretary of the election board a cashier's check or certified check in the amount of \$250.00. All persons filing a Declaration of Candidacy are referred to the State Election Board's website to obtain a Candidate Filing Packet. The packet contains, on page two, a notice to contestees that if they desire to respond to a petition contesting their candidacy, they must deposit with the election board secretary a cashier's check or certified check at the time of his or her appearance at the scheduled hearing on the contest.
- Mr. Hunter's failure to appear or answer the petition by submitting the proper 6. cashier's check or certified check in the amount of \$250.00, as required by 26 O.S. § 5-129, places Mr. Hunter in default, pursuant to 26 O.S. § 5-130.
- Pursuant to 26 O.S. § 5-130, Mr. Hunter's default constitutes an admission 7. of the allegations of the petition.
- 8. Mr. Eidson's Petition alleges, as the basis for the contest:

Mr. Hunter has been registered to vote in House District 22 for less than six (6) months, as required by 14 O.S. § 108.

- 9. The Board finds the factual allegations of the petition constitute appropriate grounds for disqualification of Contestee's candidacy.
- 10. Mr. Eidson's Petition is sustained, pursuant to 26 O.S. § 5-130, and Mr. Hunter's name will not appear on the ballot as a candidate for the office of State Representative, District 22.
