EXECUTIVE SUMMARY

INTRODUCTION

Pursuant to <u>26 O.S. § 3-130</u>, State Election Board Secretary Paul Ziriax directed county election boards across the state to conduct post-election manual tabulation audits of the Runoff Primary Election held on August 27, 2024 and the General Election held on November 5, 2024.

The post-election audits for the Runoff Primary were conducted Tuesday, September 24, 2024 through Thursday, September 26, 2024 and were open to the public. The post-election audits for the General Election were conducted Monday, December 16, 2024 through Wednesday, December 18, 2024 and were open to the public. Each County Election Board posted a public notice of the date, time and location of its post-election audit at least 48 hours in advance.

For the August 27 Runoff Primary Election, the following elections were audited:

OKLAHOMA STATE ELECTION BOARD OFFICIAL POST-ELECTION TABULATION AUDIT REPORT FOR THE GENERAL ELECTION HELD ON NOVEMBER 5, 2024

SECTION 5 - ADDITIONAL FINDINGS

Oklahoma's voting devices are designed to read marks made within the target areas or "boxes" on a ballot. In rare cases, a discrepancy may occur when a mark detected by the voting device may be viewed differently during a manual examination made by the human eye. Despite these occasional variances, neither the voting device, nor those assigned to manually count ballots, are responsible for determining the intent of the voter – only whether or not a mark was made in a particular target area.

During a post-election audit, vote count changes may occur based on these variances; however, the results of a post-election audit cannot change the certified results of an election. Post-election audits are conducted for "the purpose of maintaining the security of the election system by ensuring that voting devices and software used in a particular election correctly tabulated votes." (See 26 O.S. § 3-130.)

Details of additional findings made by county election boards during the post-election audit of the November 5, 2024 General Election can be found below.

Election Date: 11/5/2024

Election Audit: U.S. President and Vice President **Counties:** Bryan, Cleveland, Ellis, Sequoyah, Tulsa

Audit Date: 12/16/2024 - 12/18/2024

Upon auditing the votes for United States President and Vice President, five counties reported minor changes. The changes were as follows:

- In **Bryan County** Donald J. Trump and JD Vance (Republican Candidates) received one additional Election Day vote in Precinct 070024.
- In **Cleveland County** Kamala D. Harris and Tim Walz (Democratic Candidates) received two additional mail absentee votes one vote in Precinct 140213 and one vote in Precinct 140315.
- In **Ellis County** Donald J. Trump and JD Vance (Republican Candidates) received one less Election Day vote in Precinct 230001.
- In **Sequoyah County** Donald J. Trump and JD Vance (Republican Candidates) received one less in-person absentee ("early voting") vote in Precinct 680204. Robert F. Kennedy, Jr. and Nicole Shanahan (Independent Candidates) received one less in-person absentee vote in Precinct 680205.
- In **Tulsa County** Chase Oliver and Mike Ter Maat (Libertarian Candidates) received two less mail absentee votes and Donald J. Trump and JD Vance (Republican Candidates) received one additional absentee vote. The audit revealed that one vote recorded by the voting device was actually an "over vote." An "over vote" occurs when a voter makes a mark for more than one candidate in a race, resulting in a canceled vote for that particular race.

The changes did not affect the outcome of the presidential race.

Election Audit: Supreme Court, District 3

Rogers County reported a change in the vote totals for the retention of the Supreme Court, District 3 Judge with the candidate receiving one less "no" vote than the certified count. The discrepancy was discovered during a manual examination of in-person absentee ("early voting") ballots. The change did not affect the outcome of the retention question.

Election Date: 11/5/2024

Election Audit: State Representative, District 86

County: Mayes

Audit Date: 12/16/2024 - 12/18/2024

A manual audit of State Representative, District 86 revealed one additional Election Day "under vote" in Mayes County in Precinct 490311. An "under vote" occurs when a voter fails to make a mark for a race or issue on the ballot. The change did not affect the outcome of the race.
