2025: Limited and Unlimited Committees Registration & Reporting

- Quarterly reports are required of all committees. Additional reports may be required if the committee makes \$5,000 or more of Independent Expenditures or Electioneering Communications prior to an election (see IE/EC Reporting Schedule below).
- **NOTE:** State Question Committees will use the Unlimited State Question Committee Calendar instead of this calendar.

* **Required Renewal of Registration:** All limited and unlimited committees that do not (1) file a final report of Contributions and Expenditures by Dec. 31, and (2) dissolve in accordance with the Ethics Rules are required to renew their registration and pay the registration fee in January of the following year.

****Only required for limited and unlimited committees registered during the 2024 calendar year.**

2025: Special Election HD 97 Independent Expenditure (IE) & Electioneering Communication (EC) Reporting

- The additional reports for Independent Expenditures and/or Electioneering Communications below will be triggered when making IEs or ECs of \$5,000 or more in the aggregate prior to an election.
- **Next Business Day Reporting:** Once the \$5,000 threshold is met during a next business day reporting period, all additional IEs/ECs must be reported regardless of the amount.
