The Oklahoma State Maternal Health Innovation Program (SMHIP) works to address maternal morbidity and the substance use and opioid epidemic among pregnant and postpartum women by increasing access to prenatal care. treatment for substance use and maternal mood disorders, and telehealth and TeamBirth services throughout Oklahoma.

EARLY SUCCESSES

Sep 2019 - May 2021

Through the STAR Prenatal Clinic staffed by maternal fetal medicine specialists, the Oklahoma SMHIP has provided substance use services to 26 pregnant women in need. The clinic aims to reduce the large number of infants born suffering from opioid withdrawal in Oklahoma (1 infant every 25 minutes).[†]

Oklahoma SMHIP implemented an e-intervention application that allows prenatal care providers to make electronic referrals to substance use treatment providers. The CHESS Health application is available to 17 birthing hospitals participating in the Oklahoma Mothers and Newborns Affected by Opioids patient



Oklahoma SMHIP trained clinical and public health professionals under the Project ECHO model, an evidencebased training that disseminates guidance to providers through presentations and obstetric scenarios by connecting experts to local care teams.

To improve access to prenatal care for women across the state, Oklahoma SMHIP is working to:

- · Establish a statewide pilot of mobile prenatal care clinics through county health departments, including a maternal fetal medicine clinic with the Cherokee Nation.
- **Implement the Delivery Decisions** Initiative TeamBirth Project, an innovative intervention that seeks to ensure that all birthing hospital patients are listened to, educated, and included in all decision-making processes.

- ** Maternal death is defined as the death of a woman while pregnant or within 42 days of the end of the pregnancy, excluding accidents and incidental causes.

 *** Severe maternal morbidity is defined as unexpected outcomes of labor and delivery that result in significant short- or long-term consequences to a woman's health, including blood transfusions Oklahoma Department of Mental Health & Substance Abuse.
- The key partners listed in this fact sheet were identified by grantees as organizations with which they collaborate at the highest level of collaboration (Full Collaboration) on a 4-point scale. Full Collaboration describes partners who have a formal agreement with the grantee, frequent communication, pooled resources and equal decision-making.
