5. Presentation

- Accuracy of prehospital trauma scoring by EMS in a rural community hospital setting: A retrospective analysis..... Dr. David Behm
Dr. Behm made a presentation to the committee of his research of trauma scoring by EMS in rural areas. The purpose of the study was to analyze the accuracy of prehospital trauma scoring by EMS providers based on Oklahoma’s Prehospital Triage and Transport Guidelines (OPTTG) and compare those numbers to the rates of over and under-triage with American College of Surgeons Committee on Trauma standards(ACSCOT).Takeaways from the study are that 25.1% of the patients were under-triaged and 5.2 % of the patients were over-triaged, both of which do not meet the standards for trauma triage by American College of Surgeons Committee on Trauma. Based on this data there may be a need for improvement in education for EMS providers regarding trauma scoring in order to avoid inaccurate priority scoring of trauma patients.

6. Discussion, consideration, possible action, and vote to recommend..... Jamie Lee

- Revised Pre-Hospital and Interfacility Oklahoma Trauma Triage Algorithm including defined nomenclature
Ms. Lee yielded the floor to Dr. Amanda Celii, who presented the results of the group tasked with reviewing the current T3 in comparison with 2022 guidelines published by the American College of Surgeons (ACS). The committee discussed the findings and a motion was made by Dr. Caughell and seconded by Dr. McElyea to recommend the Revised Pre-Hospital and Interfacility Oklahoma Trauma Triage Algorithm including defined nomenclature with the following edits: Add the following list of comorbidities taken from the Trauma Triage Reference Manual to the Pre-Hospital T3 under the Priority 2 heading –
 - Age greater than 65 (corrected from 55)
 - Age less than 5
 - Extremes of Environment
 - Patient’s previous medical history such as:
 - Anticoagulation or bleeding disorders
 - End state renal disease on dialysis

Mr. Adkerson presented the proposed regulatory amendments medical directors, quality assurance, and benchmarks to the committee. The Committee discussed and Dr. Knoles made a motion and Dr. DaVault seconded the motion to recommend the amendments with the following edits:

OAC 310:641-1-7 Definitions

- Transport protocol – under a. nonemergency, routine transport shall be to the facility of the patient’s choice “as defined by the agencies reasonable range.”

OAC 310:641-3-63 Ambulance service files

- (d) remove the strike though from the word quality, so the regulation states: “Documentation that verifies and ongoing physician involved quality assurance problem that meets the requirements detailed in the quality assurance and improvement policy.”
- Match the language aligning with SB 1515 on page 9 (*OAC 310:641-2-3*), to the language on page 21 (*OAC 310:641-15-14*) with the change from “online medical control” to the verbiage “of the agency within the region”
