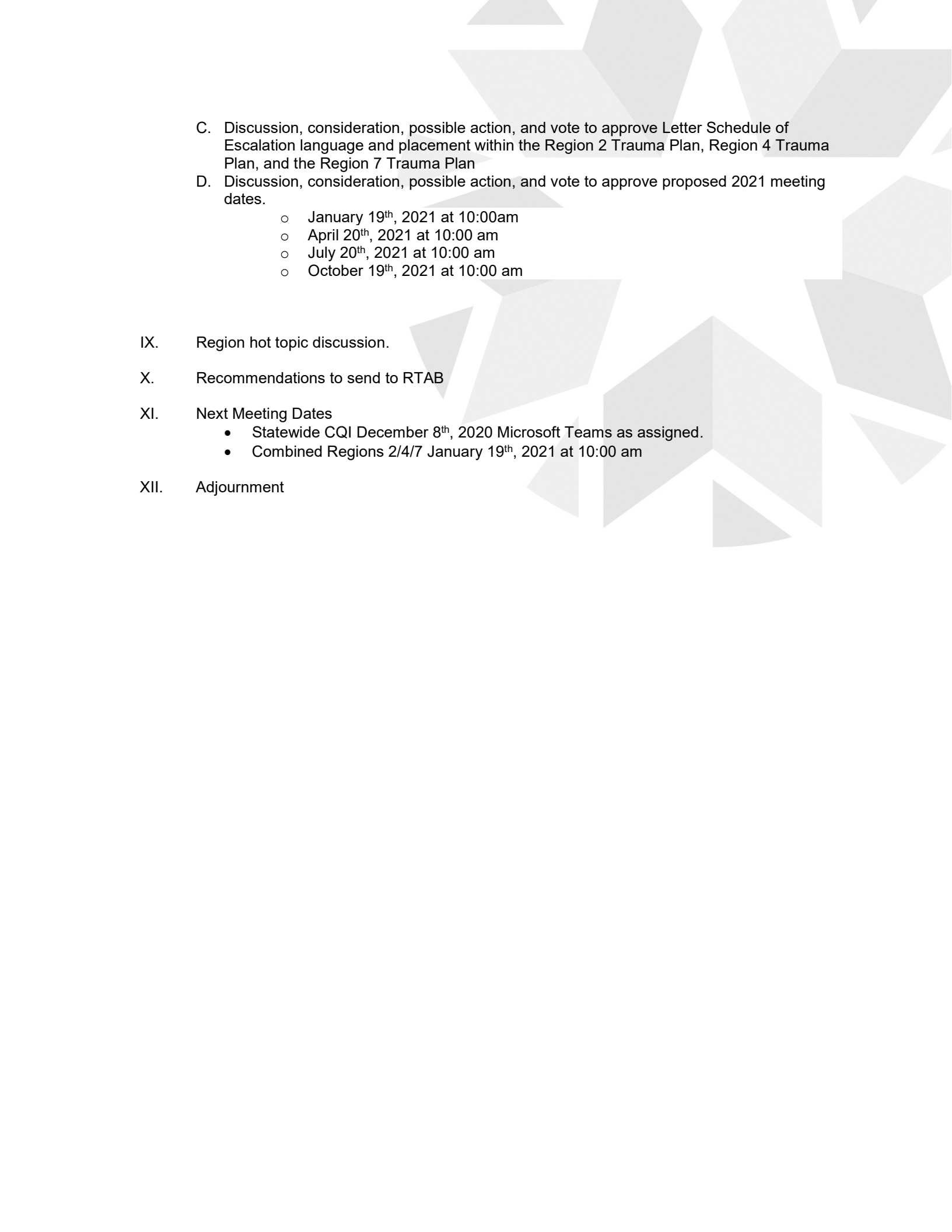

The committee also discussed potentially making a recommendation to their respective RTABs to improve the incidences of Priority 1 patients being transported to an inappropriate initial facility and agreed that the committee would support Dan Whipple's goals of a three percent reduction.
