- IV. Review of previous meeting summary-** The fourth quarter CQI meeting was held on October 13, 2020 via Microsoft Teams and was called to order at 10:00 am by Eddie Sims. There were 16 members present. New member, Mike Isaac was introduced. Jamie Lee announced OSDH staff continue to work from home. She also announced the addition of the Special Programs Coordinator, Katrina Warden, to the EMS team. Eleven cases were reviewed by the group. Three cases were closed. There were 11 letters to be authored, ten of those require responses, and one was a good job letter. The group also reviewed one response to a letter that was generated during the third quarter of 2020. It was accepted by the committee as received with no further action needed. Data from OKEMSIS and the Trauma Registry was reviewed. There was a question regarding the reported number of Priority 1 patients taken to a Level IV facility and discussion that those may need to be pulled for case review in the future. The committee voted to approve language requiring participation with CQI and placement of that language within each of their respective trauma plans. The changes for the trauma plans will be presented during the 2021 first quarter RTAB meeting and recommended for approval. The proposed 2021 meeting dates were approved by a vote of the committee. The meeting adjourned at 12:20 pm.

Three additional statewide CQI meetings were held on December 8, 2020. There were 35 CQI members from across the state that participated. A total of 30 cases were reviewed by the groups. There were 45 letters to be authored, 39 of those require responses, and six were good job letters.
