Discussion, consideration, possible action and vote to recommend to the RTAB, more about Mobile Integrated Health. A discussion took place about Mobile Integrated Health (MIH) and what MIH is about. Spencer shared that it can be many things that can utilize paramedics and EMT's who at it's core is a cooperative movement between EMS and the hospital. These people would provide out of facility visits for patients that are frequent fliers to the hospital and need care for those people that are leaving the hospital and need a little more care to prevent them from returning to the hospital within 30 days for the same problem. Becky from the State Department of Health shared what MIH was a little more and that it is often called Community Paramedicine (CP). She explained what it looked like in MN since she worked as a CP there prior to coming to Oklahoma. They will be looking into this more at the next meeting so they can bring it to RTAB. The decision was to keep it in the RPC for now until the RPC knows and learns about this further.

6. Discussion, consideration, possible action and vote to recommend to RTAB the Rural Health Transformation Plan. This transformation plan offers the entire region a standard patient transfer priority list that Woodward EMS came up with. The language was removed from the specific agency to make it for all Region 1, hospitals and EMS agencies alike. This is only a guideline for prioritizing and transferring patients. This gives hospitals reasonable expectations for prioritizing patients, and when they can expect the transfer will happen instead of wondering if the ambulance is ever going to show up.
