5. Reports

- Spencer Leiter reported they met today, October 28, 2025. They started a discussion about Mobile
 Integrated health and formed a sub-committee. Matt Miller will be leading the group and Mark Almack and
 Kate Nichols volunteered to help. We will welcome any thoughts on that subject. Spencer also asked people
 to look the trauma plan and put input into any changes that should be made. They will be looking at it at the
 next meeting.
- Chad Campbell reported the only CQI change is that the CQI Chairman resigned as chairman so according to by-laws Chad is now the chairman. CQI is now in a holding pattern until the ACS review is completed and implemented. Please keep in mind that our region is going to have to come together on how we want it to work. This will include how we do the intake on what calls to be reviewed, to how to present, and when we want to have the meeting. The other regions review the charts as a group, report it to the RTAB chair, who then takes it to the chairman of OTERAC. This is currently a talking point.
- Rob Cruz introduced himself as the new RMRS coordinator for Region 1. He is currently in Elk City. Elk City got the contract for RMRS.
- 6. Tamara Fischer did not have anything to report on the Stroke System of Care. The stroke plans are to be voted on next month, but she is unsure who will be voting. Tammy shared that most hospitals are now using TnKase instead of TPA for stroke. This has become standard in Oklahoma.
- 7. Bobbie Keith presented they are starting up the autism training. The question was asked if EMS for children is still able to provide Pedi-mates for children under 40 lbs. Ms. Keith let people know they are no longer doing this, but she does have a few left over.
- 8. CJ Lance, the representative for Oklahoma, presented on how the State of Oklahoma regions can benefit from Pulsara. There are many agencies in Oklahoma currently using Pulsara. CJ Lance presented helpful information on what Pulsara was capable of and how it would help EMS and hospitals communicate. Pulsara
