## 4. Reports:

- Grace Pelley reports that Chris Dew has elected to return to Regulatory. Epidemiologist, stat research specialist, and Trauma System Coordinator positions are open. There have been changes to OERSSIRF rules. The next OTERAC is May 3, 2023 that will include discussion on the remodeled T3. Xana Howard reminds agencies that all trauma cases must be entered into OKEMSIS. OKEMSIS training is in April with all dates for OKEMSIS and Trauma Fund included in the packet. A telehealth survey for imaging exchange will be handed out.
- Reviewed 9 cases, 1 was held for further review. 18 letters were authored with two of the letters not requiring a response. There is difficulty getting the medical records that are needed, please send a reminder to those in charge of records. Please emphasize the need to appropriately triage patients appropriately.
- REPC is working on communications as well as developing plans at a local level to further help the region. Rachel Talley will be replacing Brad LanCaster as committee chair. ATV safety awareness will be the Trauma Event for the month of May.
- Current focus is on Rural EMS Stroke Education to help implement plans and training.
- Tornado operation discussion will occur this afternoon as well as recovery planning.
   Radiation Road Show will be setting up for EMS and hospitals to walk through how to develop a plan for the patient as well as treatment for the patients.
- Pedimates are available for services that need them. Special needs awareness is underway
  as well as a safe sleep education.
- 5. David Howerton and Dr. Amanda Celii made a presentation on Whole Blood Implementation and the lessons learned for the central region. The implementation of whole blood in the central region has increased the survival rate of trauma patients after several years of developing protocols and processes to best serve the community and allow the services to be the best stewards of the blood they have in service.
- 6. Grace Pelley reports that the rotation has not gone away but has adjusted to a hand schedule. OU Health will auto accept any Priority 1 and Priority 2 trauma and EMResource has a daily report of what facilities are accepting what specialties.
- 7. A regional trauma activity will be decided amongst individual agencies for Trauma Awareness Month in May.
