- Mark Forrest shared with the committee that they did meet today at 10:00 a.m. Everyone is free to attend the meetings. The work for the Region is done at these meetings. We closed out some items we were working on this year. Tricia Fleming gave an update on the feedback from the trauma centers. She has spoken with Maryavis with Saint Francis. She has the contacts for this Region. She will start funneling the feedback to the EMS agencies. - 9. Lt. Ryan Woodard presented Autism Interaction for First Responder. He informed the committee autism spectrum disorder (ASD) is a developmental disability caused by differences in the brain. They have 3 different function levels of autism; ASD level 1 requires support, ASD level 2 requires substantial support, and ASD level 3 requires very substantial support. Central Disease Center says 1 in 44 children in the United States is Autistic. Lt. Ryan Woodward gave numerous characteristics of autistic adults, how to interact with autistic individuals, and common emergency calls. The common emergency calls include wandering/ elopement, injury (to self or others), mental health crisis, victims of a crime, and suspicious behavior. He gave the committee tips for EMS and fire fighters, search and rescue efforts, patient encounter tips, and informed the committee that

caregivers are your friends. He informed the committee to ask questions, get involved, and get equip with a sensory kit.

- 10. Commissioner for the Oklahoma Department of Mental Health and Substance Abuse Services Allie Friesen asked the committee what troubles they have in the field with mental health calls. EMS shared experiences they have had in the field. Questions are asked about transport of patients and where the responsibility falls. Discussion is had about the options that are presented outside of using police or ambulance with a contract company that has a positive impact on the community. It is reported that there has been an increase in pediatric patients with an increase in difficulty finding beds for the patients, especially those with chronic medical conditions.
