5. Reports

- Dr. Campbell reported that CQI did not meet this quarter- The CQI is still under modification and emails are being sent out to people on the committee. People on CQI need to pick the cases coming in, then the chair will receive them from Norma Perez at the state, who will then choose what cases are going to be chosen for CQI. The hope is that CQI meetings will be in full swing by the next RTAB meeting.
- Mark Forrest reported the RPC met today and they are looking for four people to join RPC. Sam Murray is
 putting together a survey to see where run reports go, how the reports are sent, whether it is by fax,
 person on scene, or some other way. In 2026. The plan is to revisit the stroke, stemi and snake bite plans
 since it has been a few years.
- Sam Murray reported a REMS conference is taking place next week.



- 6. Jennifer Thompson reported for the Stroke System of Care reminded the group that December 2025 there is a symposium being held at OU.
- 7. Bobbie Keith let everybody know the autism training is now underway, and places are needed to hold the class.
- 8. A presentation for BIG guidelines update was given by Dr. Powell. Dr. Powell started by asking, "do all brain injury patients need to be transferred to a major hospital?" If a patient is severely altered, GCS of 4, they are going to have a big head bleed. Most patients have very small head bleeds a few mm in width and do not need to be transferred. If the patient is not intoxicated, no Altered Mental Status (AMS) and presenting with no symptoms they should be discharged, with a follow-up with the patient's PCP. The physician can call a stroke hospital and talk to the Physician, but most can be observed for a few hours in the ED and sent home. They do not need to be admitted, and do not need a neurosurgery consult, they do not need seizure medication prescribed. The goal is to have them follow up at their home clinic. Prehospital treatment is not really going to change.

The decision to include a vice chair was discussed but it was not on the agenda for the RPC so will be added to the next RPC meeting on February 26, 2026 for them to discuss.
