- Lori Strider informed the committee reported the updated process for initial ambulance surveys is on the OSDH website. Also, routine agency inspections are currently being conducted. If anyone has questions about OERSSIRF, please contact Dale Adkerson or Katrina Warden.
- Katrina Warden gave updates on Trauma Fund, Trauma Registry and Research along with Compliance, Data Accuracy and Quality.
- Dr. James Campbell informed the committee that The Region 2,4,7 CQI committee reviewed 14 cases, which 22 letters were authored and needing response. The committee reviewed 14 response letters, 13 were accepted and 1 needed a follow-up letter but required no response. The next meeting is in person at OSDH on October 6th,2023.
- Tricia Fleming informed the committee that RPC did meet this morning. They discussed the antivenom plan, STEMI plan, a survey that will be going out for data on capabilities of agencies for STEMI patients, and an extrication plan. Mike Cates informed the committee that the RPC is where the planning happens and that anyone can come to help with the process of planning for the Region.
 - Sam Murray informed the committee that the next meeting is in McAlester on August 23rd, 2023 at 10:00 am.
- 5. Jennifer Thompson informed the committee she had no update from OSSSAC. Saint Francis this month had start to use a different Thrombolytic. The new medication allows for a faster push and a cheaper medication. The American Heart Association is rolling out a new certification, Advance Stroke Life Support. Training will be coming out soon.
- 6. Sarah Connally informed the committee that EMS-C is focusing on safe sleep awareness, Autism/Non-verbal training, and water safety this year. They still have Pedi-mates available if EMS needs them or needs new ones.

- 8. Christian Bonds with Injury Prevention presented a Concussion Prevention. He went over what a concussion is, the sign and symptoms of a concussion, the danger signs of a concussion, the long-term consequences from concussion, how to manage a concussion and how to prevent a concussion. Oklahoma has a state law over concussions for youth athletes; 70 O.S. § 24-155. The law was designed to protect youths' athletes in Oklahoma. A annual concussion fact sheet should be provided to parents/guardians. Team officials are required to complete a class over concussions yearly. The Training source must be from either the Center for Disease Control & Prevention (CDC), the National Federation of State High School Associations (NFHS), or other comparable source. The class covers prevention of concussion in athletes, such as safety equipment, safe sports play, culture and strong policies. Christian brought with him some material that will help school districts and youth organization create policies and guides over concussions. - 9. Planning discussion topics
 - Dr. James Campbell shared with the committee about 3 Superficial Injuries That May Hide More Serious Trauma. He stated the article was in the packet, and that simple injuries might prove to be worse than they appear. He reminded the group not to become complacent in our jobs.
 - Lori Strider reported about the new criteria for Pediatric age limits and hospital capabilities.
 - Lori Strider asked the group their opinions about the sub-categories on the EMResource page. Do the names of each category need to be renamed.
 - Dr. James Campbell reported ideas and ways to improve the professional communications between EMS and Hospital ED. There was group discussion among the RTAB members about how we can get feedback from the hospitals to the medics on how the patient's outcome is. RPC is going to look into ways to get feedback from the hospitals.
