5. Reports

- Emergency Systems

Dean Henke shared with the group if they have any questions for our department they need to email Esystems@health.ok.gov . EMS Vehicle inspections are still being scheduled online and conducted by the State Capital. Trauma Registry compliance reports will be placed in BOX and there is upcoming training on how to use BOX. For OKEMSIS and Trauma Registry, those reports must be submitted by 30 days after the previous month. Mr. Henke reported that the Trauma Funds are for Physicians, Hospitals, and EMS to receive funds for unreimbursed trauma calls. All training for BOX, OKEMSIS, Trauma Fund, and Trauma Registry are in your packets, or you can email Esystems@health.ok.gov .

- Continuous Quality Improvement Committee

Nate Toews reported the last met on January 31, 2024 and they reviewed 10 cases and sent out 16 letters requiring responses. There are some outstanding letters up to two years old, but the committee is working to get the process up to date. The committee needs a couple physicians for the group. Mr. Toews discussed some trends such as lack of urgency, non-therapeutic, and hospitals not using the same triage methods as the EMS. Delbert Gay shared documentation is important because “if you didn’t write it down, it didn’t happen”

- Regional Educational Planning Committee (REPC)

Kari Beggs reported the started the review of Region 5 Trauma Plan to report to the RTAB at their next meeting. Ms. Beggs shared the committee will update the Trauma Patient Destinations by reaching out to all EMS Agencies in Region 5 to get the latest destinations that the agency transports to. Take Marshall County out of Region 5 and some verbiage changes throughout the plan. REPC is reviewing the Envenomation Plan to remove the number of vials listed by each hospital and to add Poison Control as a point of contact.

- Regional Medical Response System (RMRS)

Kari Beggs reports that the is preparing for the Solar Eclipse to occur in April, 2024. Ms. Beggs shared the RMRS has been working with the counties in Region 5 for the last several months and she feels they have a very solid plan. Law Enforcement agencies and strike teams will start to set up on the Wednesday before in some of the counties such as Choctaw, Pushmataha, McCurtain and LeFlore. For the Health and Medical Plan, they will send a Strike Team to McCurtain County. For more information or questions contact Ms. Beggs at RMRS.

- Discussion about recommendations to advance to OTERAC the need for statewide EMS education emphasizing appropriate documentation and appropriate application of triage for trauma patients based on trends identified through the CQI process started with Delbert Gay saying the Education Committee (EC) discussed state license renewal for medics. Pamela Cunningham shared that having documentation education would help the medics when they have a CQI review.
