Trauma Fund training is hospital Trauma Fund Application training is scheduled for October 26, 2022, Physician Trauma Fund Application training is November 9, 2022, and EMS Trauma Fund Application training is November 16, 2022. Chris Dew gave more information about Trauma Fund. If hospitals don't put data in Trauma Registry the physicians will not be able to apply for Trauma Fund.
