## 5. Reports

- Jeremy McLemore shared with the committee that RPC did meet this morning with primary discussions being the BIG guidelines progressing across the state regions, the ACS state survey is coming up and we felt it was best to wait to hear what they have to say regarding things we will need to work on. We are looking into scope of practise regarding paramedicine. REACT ambulance is trying to get whole blood on the ambulance service was also a discussion and how getting whole blood into rural areas may be a good thing. Two people resigned from the RPC board so we are looking for a couple people to join us so we can vote you on at the next meeting. Two people stated they would like to join.
- Judy Dyke shared with the committee that CQI has not met yet, but confidential agreements are currently being signed. Norma shared that there should be cases to review soon and will be shared with the chairs who will share with the members. If anyone has not yet received an email from Norma send an email to CQI@health.ok.gov and she will get you set up. There may be old information that needs to be updated. Box will no longer be used to communicate. The email is secure, and all referrals will need to be sent.
- Region 7 Response Coordinator Melinda Belcher not in attendance but John from RMRS gave an update that a budget reduction did occur.
- 6. Cameron Richardson shared with the committee he did not have an update from the State regarding the State Stroke Registry. The state stroke plans is still working on language for those to be consistent with all regional plans. There are two upcoming educational opportunities, OU is having a stroke symposium on August 23, 2025. The 2<sup>nd</sup> is the trauma and stroke symposium at St. Francis on September 19, 2025, so be sure to save the date.

- 8. A presentation from Jami Spradlin was given regarding Youthful Drunk Driving. There was lots of good information given, and statistics were given regarding youth and drunk driving, every 42 minutes somebody is killed by a drunk driver. In a 2023 statistic there are 12,429 people died from alcohol impaired accidents. See Jami if you want to know more about it. Jami uses her presentation to talk to teens and kids.
- 9. Discussion, consideration, possible, action and vote on how to treat burn patients who also suffer from traumatic injuries and if the trauma Plan should be reviewed. This was brought up at this time due to the 4<sup>th</sup> of July activities and things that happened. Typically, patients are brought to Hillcrest for burns or Integris Burn Center in Oklahoma City. Dr. Tyler suggested that something should be done so EMS knows where to take these patients. It was decided that this would be sent on to the RPC next quarter to be discussed in more detail. Judy Dyke will review protocols at Air Evac.
- 10. The committee discussed whether 2026 RTAB board members who have higher call volumes such as Pafford EMS Claremore should be put on the board. This discussion will be moved to the next meeting agenda due to Pafford EMS Claremore is already on the board in region 2. This will be brought up to Pafford if they want to join Region 7 instead of region 2. Somebody is going to talk to Pafford to see if they would want to do this.
- 11. Discussion took place about the 2026 Committee members for the RPC since Vanessa Bearden and Shawn Burch resigned due to changes in position. Kris Hill is also no longer with Hillcrest so will not be available to be on the RPC committee. The committee had two people volunteer to join, Jami Spradlin and one other. These positions will be voted on at the next RTAB meeting. Discussion also took place regarding the 2026 committee members for CQI. The vote will take place at the next meeting.
