## 5. Reports

- Dean Henke reported that EMS/EMRA surveys are coming out in December of each year. He
  explained there are two options due to the years you are to renew. Initial vehicle inspections can be
  scheduled on the OSDH website. Region 6 RTAB hosted an Oklahoma Trauma Education Program
  at their 3<sup>rd</sup> quarter meeting. The goal is to make updates and post the course on the OSDH website.
- Xana Howard reported Trauma Fund: In your packet is the Projected Timelines and Activities for April 2024 for claims July 1 to December 31, 2022 and October 2024 for claims January 1 to June 30, 2023. The application period will open on October 27, 2023. The deadlines are as follows: Hospitals - November 30, 2023 and EMS & Physicians - December 15, 2023. Trauma Registry and OKEMSIS. All trauma and EMS data for January thru August 2023 is past due. If you did not receive your compliance report when signing in, please see me after the meeting so that you can take the report back to your CEO. If you have no cases or PCRs to report each month, please email esystems@health.ok.gov. The Trauma Registry Vendor, ESO, has implemented national changes to Trauma Registry. Both OSDH and ESO are aware of the NTDB Discrepancies and are working on the issues. Training Opportunities: Our next virtual training will be Tuesday November 7<sup>th</sup> for Basic and Wednesday November 8th for Advanced. Our next virtual training for OKEMSIS will be November 29th, training for Medics will be in the morning and training for Directors will be in the afternoon. - 6. Sarah Connally shared information about the Pediatric Emergency Care Coordinator (PECC) and the training required. During COVID the number of PECC's decreased. Having a PECC is recommended by numerous agencies such as American Academy of Pediatrics, American College of Emergency Physicians, and many more. - 7. Cameron Richardson gave an update on the Oklahoma State Stroke Systems Advisory Committee (OSSSAC) and Oklahoma State Stroke Coordinators and Resources (OSSCAR). There has been a change to the policy from "administration of an FDA-approved thrombolytic agent" to "administration of an appropriate thrombolytic agent", the bid for vendors for a Stroke Registry has been closed out by OMES. The data dictionary has been completed. Regional Stroke plans are being developed now. They are looking for volunteers to help create a Stroke plan for Region 7. The committee is voting for Chair and Co-Chair. At one point they would like to add on EMResource something that is specific to stroke. The committee is trying to get a level of care similar to trauma patients. In your packet there is a list of learning opportunities, helpful resources, and 2 articles.
