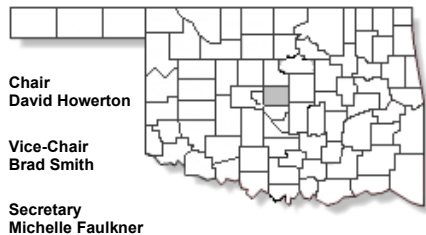
Trauma Rotation Committee was unable to meet due to quorum.
