- **1.** Dr. Leverett opened the meeting at 10:00 a.m. by welcoming everyone to the Oklahoma State Medical Association.
- 2. Ms. Epps gave proof of meeting notice, took roll call, and declared a quorum.

# 5. Possible Discussion, Revision, and Vote to Approve Minutes of the March 24, 2022, Commission Meeting – Dr. Leverett

Dr. Leverett asked for any revisions or discussion of the March meeting minutes then called for a vote.

Dr. Bushman made the motion to approve the March 24, 2022, minutes as presented. Dr. Subera seconded the motion. Voting in favor were: Dr. Leverett, Dr. Bushman, Dr. Khoury, and Dr. Subera. None were opposed.

## 6. Director's Report - Ms. Thompson

## a. HB 2776 - Legislation Update

HB 2776 has passed

PMTC is currently undergoing a name change to Health Care Workforce Training Commission. The commission makeup will continue as before with the addition of two registered nurses.

HWTC will be a sub recipient for ARPA funds for the nursing program 21 programs will be administered by HWTC.

Appropriations and decisions are expected to go into effect September 1, 2022.

Ms. Thompson will meet with Guide House and 929 Strategies for guidance and what the expectations are of legislature.

Ms. Thompson will also meet with the Office of Management and Enterprise Services to discuss federal guidelines that are incorporated with the additions.

A \$250,000 upfront funding was approved by the joint committee to be made available for the start-up phase on September 1, 2022.

### b. Office and Staff Modernization

Dana and Michelle are currently administering 225 nursing contracts, in comparison to other agencies where individuals are administering on average 25 to 30 contracts. Kami and one additional person are currently administering 121 contracts for the Physician and Physician Assistant side.

Staff re-distribution of tasks and the addition of an Administrative Tech. will assist with the overseeing of contracts.

Dana Morphew is the new program officer for the nursing department, and Karen Epps has been added as the Administrative Assistant.

Office expansion is underway to increase workstations. The additional workspace will allow for hotel style work locations. Staff operate with laptops keeping administrative costs down and to facilitate and accommodate more staff members.

Dr. Leverett raised concerns about being adequately staffed.

Ms. Thompson shares those concerns and lack of direction but is optimistic about upcoming meetings with Guide House and 929 strategies.

Dr. Bushman inquired about work hours per week/month to maintain a nursing contract and suggested looking into an automated system to reduce some of the workload.

#### 10. TSET Presentation and Questions – Julie Bisbee

Julie Bisbee Director of Programs and Lauren Ford Policy Director addressed the committee and provided an overview of TSET and their mission which is to improve health and quality of life through accountable programs and services. TSET has been in partnership with PMTC since 2013, through PMTC 48 doctors have been placed in Oklahoma's rural and medically underserved areas. The first 8 graduates of the PMTC program remain in underserved areas.
