- 4. Consideration and Possible Action to Authorize the Director to Begin the Permanent Rulemaking Process, in Order to Bring Agency Rules in Alignment with Changes to the Agency Name and Make Chapter 55 Rules Permanent Maria Maule/Ms. Thompson
