- **1.** Dr. Leverett opened the meeting at 10:00 am. by welcoming everyone to the Oklahoma Health Care Workforce Training Commission.
- 2. Ms. Fullingim gave proof of meeting notice, took roll call, and declared a quorum.

 - Dr. Leverett read the Mission Statement of Oklahoma Health Care Training Commission.

- 5. Possible Discussion, Revision, and Vote to Approve Minutes of the March 23, 2023, Commission Meeting

Dr. Bushman made the motion to approve the March 23, 2023, minutes as presented. Mr. Khoury seconded the motion. Voting in favor were: Dr. Bushman, Mr. Khoury, and Dr. Leverett, Dr. Subera abstained. None were opposed.

6. Director's Report - Ms. Thompson

- National Grants Conference Attendance
 - Ms. Thompson and Ms. Librandi attended. They split up to attend different break out sessions to gain more knowledge of the ARPA Grants the commission is managing. They both agreed it was valuable training and time well spent.
- Physician Loan Repayment Research
 - Ms. Thompson shared that Texas, Arkansas, Missouri, Kansas and Colorado all offer Federal dollars with loan repayment and most of them have the same rules, but are not restricted to rural practice, or primary care. Their funding amounts were comparable to HWTC. Ms. Thompson suggested that we begin to travel to other states to conventions for rural and family practice for recruitment purposes.
