



Memorandum of Understanding between Oklahoma Department of Libraries (ODL) and Oklahoma Museums Association (OMA) for the webinar titled “Creating a Culture of Security, Prevention of Security Emergencies, and How to Respond,” to be held in the Spring of 2024.

The Oklahoma Department of Libraries confirms that the Oklahoma Department of Libraries, through the Oklahoma Historical Records Advisory Board, with funding support from the National Historical Publications and Records Commission through its 2021-2024 grant, will provide \$500.00 for workshop expenses for the webinar titled “Creating a Culture of Security, Prevention of Security Emergencies, and How to Respond” to be offered before May 1, 2024.

The Oklahoma Department of Libraries will provide:

- Workshop expenses, including the speaker fee, for the webinar titled “Creating a Culture of Security, Prevention of Security Emergencies, and How to Respond,” currently scheduled for March 1, 2024, for a total not to exceed \$500.00. In the event of a date change, the webinar will take place prior to May 1, 2024.
- Marketing assistance, including announcements through Oklahoma Department of Libraries social media and listservs.

The Oklahoma Museums Association will provide:

- Marketing and registration for the webinar, as well as information about the support provided by the Oklahoma Department of Libraries and Oklahoma Historical Records Advisory Board, with the funding support of the National Historical Publications and Records Commission.
- Post webinar, OMA staff will provide participants with an evaluation survey which will include a request for participants to share key take-aways from the webinar.
