  - **3.1.** Changes (2019) to the *Oklahoma Nursing Practice Act*: J. Ward summarized changes to the *Oklahoma Nursing Practice Act* that went into effect on May 21, 2019.
  - 3.2 Changes (2019) to the *Rules of the Oklahoma Board of Nursing*: J. Ward summarized changes to the *Rules of the Oklahoma Board of Nursing* that went into effect on July 25, 2019.
  - **3.3 Update on Nurse Licensure Compact:** J. Ward provided an update on the NLC. Ms. Ward reported the Agency has processed 4,187 multistate license applications during FY 2019. The applications received consist of 56% existing licensees, 32% examinations and 12% endorsements.
  - **Board of Nursing guidelines approved at the September or November, 2018 Board meeting**: G. Stafford addressed revisions approved by the Board to the following: Delegation of Nursing Functions to Unlicensed Persons, #P-02; Wound Debridement by Licensed Nurses Guidelines, #P-05; Discussion Guidelines for APRNs When Prescribing Opioids, #P-55; Exclusionary Formulary for APRNs with Prescriptive Authority, #P-50B; CRNA Inclusionary Formulary, #P-50A; Monitoring of Moderate (Conscious) Sedation Patient by Licensed Practical Nurse Guidelines, #P-07; and Moderate (Conscious) Sedation Guidelines for Registered Nurse Managing and Monitoring Patients, #P-06.

- **3.5 APAC membership:** G. Stafford reviewed the term expirations of Jill Nobles-Botkin, Leanna Harkess and Steve McKitrick. Each association has been notified of the representative's term expiration.
- **3.6 Other:** G. Stafford reviewed statute changes to prescriptive authority renewal requirements and physical therapy referrals. G.
