- **3.3 SB 388 Home Health Admission Orders:** G. Stafford summarized amendment to the Act, which now allows Certified Nurse Practitioners and Clinical Nurse Specialist to certify home health admission orders. The amended section of law is retroactive and shall apply to any eligibility certification conducted on or after March 27, 2020.
- **3.4 HB 2009 Signing of Death Certificates:** G. Stafford summarized changes which will allow Advanced Practice Registered Nurses to sign Death Certificates. The effective date is November 1, 2021.
- **3.5 APAC membership:** G. Stafford reviewed the term expirations of D. Pointer, M. Rosales, C. Stewart and T. Walker. Each association has been or will be notified of the representative's term expiration.
- **3.6 Other:** G. Stafford reviewed information required on prescriptions issued by Advanced Practice Registered Nurses (APRNs) and explained the need for recent communication sent to APRNs.
