 - **3.1.** House Bill 1886-Effective November 1, 2017: J. Ward shared changes to the *Oklahoma Nursing Practice Act* that went into effect November 1, 2017.
 - 3.2 Proposed amendment to the Oklahoma Nursing Practice Act (House Bill 2518): J. Ward summarized House Bill 2518 and proposed changes related to the Oklahoma Nursing Practice Act. The changes include new language pertaining to service of a Board order to a nurse; and, clarifying language within the Criminal Background section of the Nursing Practice Act that if an individual has been continuously enrolled in the Federal Bureau of Investigation's Rap Back service since issuance of the initial multistate license, the individual is not required to undergo another criminal history record search.
