6.1 Educational presentation on registered nurse placement of nasogastric tube in patients post bariatric or anatomy altering surgery of the upper gastrointestinal tract and stomach

J. Ward presented an educational session and materials on registered nurse placement of nasogastric tube in patients post bariatric or anatomy altering surgery of the upper gastrointestinal tract and stomach. Ms. Ward also discussed survey data obtained by the National Council of State Boards of Nursing regarding whether or not other State Boards of Nursing have addressed Registered Nurse placement of nasogastric tubes in post-bariatric and anatomy-altered post-surgical patients. Representatives from Integris Baptist Medical Center, Sarah Kitchen and Susie Jones, were present to address the Board. The representatives provided background information on their request to the Nursing Education and Nursing Practice Advisory Committee. Due to the anatomical changes in the upper gastrointestinal tract, there is an increased risk of complication when an NG tube is placed. Some facilities have specific policies that prohibit nurses from placing NG tubes on these patients, but in many cases, the representatives indicated that no guidance is provided to the nurse. The Integris Baptist staff stated that they were unable to identify national standards or best practices related to this act in their literature search and are looking to the Oklahoma Board of Nursing for assistance.

Board members directed the issue to be placed as a decision item on the agenda for discussion at the January 2011 Board meeting.
