 - 3.1 **Board of Nursing update:** G. McNish reported on amendments to the *Oklahoma* Nursing Practice Act. These amendments became effective November 1, 2011. G. McNish reported on revisions to the Rules of the Oklahoma Board of Nursing. The resolution to approve the *Rules* was passed in the House of Representatives and will next be reviewed in the Senate. If it is passed in the Senate and signed by the Governor, the revised *Rules* will take effect July 1, 2012.
 - 3.2 CRNA Formulary Advisory Council appointment expirations: All Council members are current.
- 4.0 Review and committee recommendations on revisions to CRNA Inclusionary Formulary: Council members reviewed the CRNA Inclusionary Formulary and a draft of proposed revisions. A list of new and updated monographs was provided to committee members. The proposed revisions add new cross-references; identify drugs that remain on the market but for which no monograph is provided in the current edition of the AHFS Drug Information Manual; identify drugs that have been taken off the market; and add AHFS classification changes.

After discussion, it was moved (E. Yen) and seconded to submit the following revisions to the CRNA Inclusionary Formulary, #P-50 to the Board for approval:

- the cross-classification of Benztropine Mesylate anticholingeric agents. Benztropine Mesylate remains in 28:36.
- Delete Ritrodrine Hydrochloride, which has been taken off the market, under 12:12.04.
- Add Cisatrachurium to 12:20.20.
- Specify the subclassification of 28:04.16 Inhalation Anesthetics under 28:04.
- Delete Thiopental, which has been taken off the market, under 28:04.04.
- Specify Ketamine in the list of approved drugs under 28:04.92.
- Add astericks to Phenobarbital, Temazepam, Benzonatate, Antacids, Benzocaine, Dibucaine, Doxepin, Ethyl Chloride, Phenazopyridine, and Pramoxine, to denote that the information on these drugs has been omitted from the print version of AHFS Drug Information.
