- 3. Verbal reports requiring no action by committee.
  - 3.1. Changes to the *Oklahoma Nursing Practice Act, effective November 1, 2019*: J. Ward reviewed changes to the *Oklahoma Nursing Practice Act* that were approved in Senate Bill 81 and Senate Bill 848.
  - 3.2. **Proposed Emergency** *Rules of the Oklahoma Board of Nursing*: J. Ward reviewed the proposed emergency rules changes submitted by the Oklahoma Board of Nursing on September 25, 2019, to the Governor, Speaker of the House of Representatives and the President Pro Tempore of the Senate. Related to the Governor's approval/disapproval timeline, the Board expects to hear of the approval or disapproval of the emergency rules by November 12, 2019.
  - 3.3. Update on enhanced Nurse Licensure Compact (eNLC): J. Ward reported that 34 states have enacted the eNLC, and 31 of those states have implemented the compact. Alabama will implement January 1, 2020; and, Indiana and New Jersey have not set implementation dates. The average time for Board staff to process MSL applications for existing licensees is 1 day.
