- **1.0 Call to Order:** The meeting was called to order by R. Kimball-Potter, Vice Chairperson, at 2:47 PM.
 - 1.1 Declaration of quorum: A quorum was declared present.
 - 1.2 Role of the Council: G. Stafford defined the role of the Council.
- 2.0 Council decision regarding approval of council meeting minutes for March 14, 2019: It was moved (J. Kinnard) and seconded to approve the minutes of March 14, 2019.

3.0 Verbal reports requiring no action by committee:

- 3.1 Changes to the *Oklahoma Nursing Practice Act*: J. Ward summarized changes to the *Oklahoma Nursing Practice Act* 59 O.S. § 567.3a (10).
- **3.2** Review of revisions of the Rules of the Board: J. Ward summarized changes to the Rules of the Oklahoma Board of Nursing that went into effect on September 11, 2020.
- **3.3 Optimal Regulatory Board system (ORBS):** J. Ward provided a summary of the features with the ORBS Licensing Database including the Verification Portal, Nurse Portal, Complaint Portal and Message Center.
- 3.4 Executive Orders related to COVID-19: J. Ward provided an overview of Executive Orders filed since March 12, 2020 when Governor Stitt urged Oklahoma to be ready for the threat of COVID-19. A review of the most recent Executive Order, the Sixth

- Amended Executive Order 2020-20, filed on October 24, 2020, was reviewed as it related to the occupation of nursing.
- 3.5 FAC membership expiration dates: G. Stafford updated the Council on the membership terms which have expired and the request of one member to end his service. Deborah Booton-Hiser, APRN, Susie Jones, APRN, Tim Anderson, DPh, Mary Jane Fry, Pharm. D, Meri Hix Pharm. D, and Robert Holsey, DO have completed their terms of appointment to the Formulary Advisory Council. Dr. Harold Ginzburg, MD has asked his association to appoint a new member to replace him due to his current job requirements.
- **3.6 FAC new membership appointments:** G. Stafford introduced the six new members appointed to serve on the Formulary Advisory Council. Tracy Langley, APRN and Kathy O'Dell, DNP, RN have been appointed by the Oklahoma Board of Nursing. Denton Chancey, DPh, JJ Peek, DPh, and Kacee Blackwell, DPh have been appointed by the Oklahoma Pharmacists Association. Jason Regan, DO has been appointed by the Oklahoma Osteopathic Association.
- 4.0 Review and recommendations to the Oklahoma Board of Nursing on the Exclusionary Formulary for Advanced Practice Registered Nurses with Prescriptive Authority, #P-50B:
 - **Discussion regarding new drugs:** G. Stafford reported the process for reviewing the Exclusionary Formulary. Review included all new drugs assigned classification in the 2020 American Hospital Formulary Service Drug Information Book since the last meeting, March 14, 2019; and review of all new drugs in the 2019 American Hospital Formulary Service Drug Information Book up until this meeting date. The council reviewed the drug lists; there was discussion regarding Remimazolam, a new anesthesia The council determined Remimazolam should be placed on the Exclusionary Formulary. The Exclusionary Formulary is utilized by Certified Nurse Practitioners, Clinical Nurse Specialists, and Certified Nurse Practitioners for prescribing in accordance with their scope of practice, anesthesia is not included in their scope of practice. Anesthesia is in the scope of practice for Certified Registered Nurse Anesthetists, who utilize the CRNA Inclusionary Formulary, which does include Remimazolam. Other discussion included the drug Ketamine, which is now included in the 2020 American Hospital Formulary Service Drug Information Book. The decision was made to leave Ketamine on the Exclusionary Formulary. It was decided to remove all asterisks, because the need to identify omitted drugs from the printed version did not enhance the Exclusionary Formulary.
 - **Recommendations:** The recommendations for changes include adding the drug Remimazolam, removing all asterisks, updating references and removing the language "not in AHFS" by the drug Ketamine.
