- **3.1** Changes to the *Rules* of the Oklahoma Board of Nursing: J. Ward summarized changes to the *Rules of the Oklahoma Board of Nursing*.
- **3.2 HB 2873 Universal Licensing Recognition Act:** J. Ward summarized the Universal Licensing Recognition Act.
- **3.3** SB 388 Home Health Admission Orders: G. Stafford summarized amendments to the Act, which now allows Certified Nurse Practitioners and Clinical Nurse Specialist to certify home health admission orders. The amended section of law is retroactive and shall apply to any eligibility certification conducted on or after March27, 2020.
- **3.4 HB 2009 Signing of Death Certificates:** G. Stafford summarized changes which will allow Advanced Practice Registered Nurses to sign Death Certificates. The effective date is November 1, 2021.
- **3.5** Medication Assisted Treatment (Buprenorphine): G. Stafford summarized new Buprenorphine Practice Guidelines expanding Medication Assisted Treatment for Opioid Use Disorder which were released by the Department of Health and Human Services (HHS) April 27, 2021.

3.6 FAC membership: G. Stafford reviewed the current membership, including new member, J. Cotton, and upcoming term expiration dates for R. Potter-Kimball and J. Regan.

4.0 Review and recommendations to the Oklahoma Board of Nursing on the *Exclusionary Formulary for Advanced Practice Registered Nurses with Prescriptive Authority,*#P-50B:

• **Discussion regarding changes:** G. Stafford reported the process for reviewing the *Exclusionary Formulary*. Review included all new drugs assigned classification in the *American Hospital Formulary Service Drug Information Book* since the last meeting. The Council reviewed the proposed changes to the formulary including; additional language to introduction which identifies the information to be included on all prescriptions issued by Advanced Practice Registered Nurses, removal of an asterisk, reorganization and identification of Anesthetics, Opiate Agonists, and Benzodiazepines using the AHFS Drug Classification and Reference Numbers. Members did review FDA warnings on Lybalvi, Qelbree, and Qdolo. After discuss, these drugs were not added to the *Exclusionary Formulary*.
