- 3.0 Verbal reports requiring no action by committee:
  - 3.1 Board of Nursing update
    - **3.1.1** Revisions to the *Rules of the Oklahoma Board of Nursing:* G. McNish reported that revisions to the *Rules* are currently under development to implement the amendments in the ONPA. Once the revisions are complete, they will be reviewed by the Board and a decision will be made regarding moving forward with the proposed revisions. If approved by the Board, the revisions will go through an administrative rulemaking process, and if approved, they will take effect July 1, 2012.
    - **3.1.2 Revisions to CRNA Inclusionary Formulary:** J. Ward reported on revisions to the CRNA Inclusionary Formulary, which were recommended by the CRNA Formulary Advisory Council and approved by the Board in May 2011.
    - **3.1.3** Amendments to the *Oklahoma Nursing Practice Act*: G. McNish reported on amendments to the *Oklahoma Nursing Practice Act*, which will take effect November 1, 2011.
  - 3.2 Other reports:

- 4.0 Review and recommendations to the Oklahoma Board of Nursing on the revisions to Advanced Practice Nurses with Prescriptive Authority Exclusionary Formulary -#P-50B:

- **4.1 Draft revisions proposed by staff:** J. Ward reported the process for reviewing and revising the *Exclusionary Formulary*. Revision included updating categorization as reflected in the *2011 American Hospital Formulary Service Drug Information Book*, moving a description of the purpose of the Exclusionary Formulary from the end to the beginning of the policy, and updating titling.
- **4.2 Discussion and decision on the prescription of disease modifying- antirheumatic drugs by advanced practice nurses:** The Council discussed the presence of gold compounds on the *Exclusionary Formulary* and whether other disease-modifying antirheumatic drugs should be added to the *Exclusionary Formulary*. The Council requested that, prior to the next meeting, Board staff obtain information from currently-practicing advanced practice nurses to determine whether these drugs are currently being prescribed, as well as gather additional information on these drugs to determine whether they should be included or removed from the *Exclusionary Formulary*.
- **4.3 Other revisions:** No other revisions were proposed by the Council members.

It was moved and seconded that the draft revisions be submitted as presented to the Oklahoma Board of Nursing for approval.
