

## HEARINGS AND CONFERENCES

Language in Board Orders directs **automatic revocations, suspensions or temporary suspensions** when licensees or applicants violate existing Orders of the Board. Listed below are licensees or applicants with suspensions, revocations or temporary suspensions after the **May 2024** Board Meeting. The Subsequent Action taken due to non-compliance by the licensee of an existing Board Order changes licensure status which may be listed for a licensee or applicant with the May 2024 Board Hearings and Conferences, which follow the Subsequent Actions list.

Other suspensions of licenses occur in compliance with statutes, including but not limited to: **59 OS § 567.17 I.** *The Executive Director of the Board shall suspend the license immediately upon notification that the licensee has defaulted from the peer assistance program, and shall assign a hearing date for the matter to be presented to the Board, ;* **59 OS § 567.7 E.** *The Executive Director shall suspend the license or certificate of a person who submits a check, money draft, or similar instrument for payment of a fee which is not honored by the financial institution named. The suspension becomes effective ten (10) days following delivery by certified mail of written notice of the dishonor and the impending suspension to the person's address on file. Upon notification of suspension, the person may reinstate the authorization to practice upon payment of the fees and any and all costs associated with notice and collection. The suspension shall be exempt from the Administrative Procedures Act. ;* and **59 OS § 567.8 N.** *The Executive Director shall immediately suspend the license of any person upon proof that the person has been sentenced to a period of continuous incarceration serving a penal sentence for commission of a misdemeanor or felony. The suspension shall remain in effect until the Board acts upon the licensee's written application for reinstatement of the license.*
