COUNT 1: RAPE IN THE FIRST DEGREE,

Title 21 O.S. §§ 1111 & 1114, a FELONY


COUNT 2: LEWD OR INDECENT ACTS TO A CHILD UNDER 16,

Title 21 O.S. § 1123, a FELONY

IN THE NAME AND BY THE AUTHORITY OF THE STATE OF OKLAHOMA:

By the order of the Supreme Court of Oklahoma, the Twenty-First Multicounty Grand Jury was convened with its principal site to be in Oklahoma City, Oklahoma County, Oklahoma, to serve from December 16, 2024, for eighteen (18) months, or until the designated presiding judge determines the Twenty-First Multicounty Grand Jury has reached reasonable completion of its investigations, but, in any event, no more than twenty-four (24) months from the commencement of its term. That said Multicounty Grand Jury of the State of Oklahoma, being composed of good and lawful men and women, legally drawn and summoned according to law, and then and there examined, impaneled, sworn, and charged according to law to diligently inquire into, and true presentment make, of all public offenses against the State of Oklahoma committed and triable within the State of Oklahoma, upon their oath, and in the name and by the authority of the State of Oklahoma, do present and find:

COUNT 1: RAPE IN THE FIRST DEGREE, Title 21 O.S.Supp. 1983, §§ 1111 & 1114 On or about or between May 1, 1984, and October 1, 1984, the crime of RAPE IN THE FIRST DEGREE was feloniously committed in Tulsa County, State of Oklahoma, by JOSEPH LYLE CAMPBELL who willfully and knowingly accomplished the act of sexual intercourse with ______, who was eleven (11) or twelve (12) years old at that time, by inserting his penis into the vagina of _____, while in the garage area of his parsonage, contrary to the provisions of Sections 1111 and 1114 of Title 21 of the Oklahoma Statutes and against the peace and dignity of the State of Oklahoma.



COUNT 2: LEWD OR INDECENT ACTS TO A CHILD UNDER 16, Title 21 O.S.Supp.1983, § 1123

On or about or between March 1, 1984, and December 1, 1984, the crime of LEWD OR INDECENT ACTS TO A CHILD UNDER 16 was feloniously committed in Tulsa County, State of Oklahoma, by JOESPH LYLE CAMPBELL who did intentionally touch or feel with his hand the body or private parts, including the breasts and vaginal area, of who was fourteen (14) years old at that time, in a lewd or lascivious manner, while at the Eastland Assembly of God Church, contrary to the provisions of Section 1123 of Title 21 of the Oklahoma Statutes and against the peace and dignity of the State of Oklahoma.
